Please be advised that the **Republic Act 10931, known as the Universal Access to Quality Tertiary Education Act**, remains in effect across all Romblon State University Campuses and Colleges. This act provides free tuition and other school fees for all eligible undergraduate students in state universities and colleges (SUCs), including those with disabilities (PWDs).

Under RA 10931, Filipino undergraduate students who meet the university's admission and retention requirements remain eligible for free tuition and other school fees. This program also ensures support for Persons with Disabilities (PWDs), aligning with our commitment to providing inclusive education for all students.

Campus Directors, College Deans, and Campus TES Coordinators are encouraged to stay updated with the guidelines and requirements associated with RA 10931 to support accurate communication and guidance for eligible students.
