SUBJECT : STRICT IMPLEMENTATION OF NO SMOKING POLICY AND
COMPREHENSIVE TOBACCO CONTROL

DATE : August 14, 2023

Pursuant to Section 8 and (o) of Republic Act No. 7722, the Higher Education Act of 1994, in relation to Section 5 (a) of Republic Act No. 9211, the Tobacco Regulation Act of 2003, and in accordance with Civil Service Commission (CSC) Memorandum Circular No. 17, s. 2009, CSC-DOH Joint Memorandum Circular 2010-01, Executive Order No. 26, s. 2017, and Article 5.3 of the WHO Framework Convention on Tobacco Control, this memorandum is hereby issued to strengthen and reinforce the implementation of a 100% smoke-free and tobacco-free environment within Romblon State University.

I. SCOPE

This policy applies to:

1. All buildings, facilities, grounds, and vehicles owned, leased, or operated by the University;
2. All indoor and outdoor areas within the University premises;
3. All members of the University community including faculty, staff, students, and visitors; and
4. All University-sponsored events and activities, whether on or off-campus.

II. PROHIBITED ITEMS AND ACTIVITIES

The following are strictly prohibited within University premises:

1. Smoking of any tobacco product;
2. Use of electronic cigarettes (e-cigarettes) or vaping devices;
3. Use of heated tobacco products;
4. Chewing or consumption of any tobacco products;
5. Sale, distribution, or advertisement of tobacco products;
6. Acceptance of any form of tobacco industry sponsorship;
7. Failure to disclose financial interest in the tobacco industry; and
8. Any acts analogous to the foregoing.

III. SPECIFIC PROVISIONS

1. Signage Requirements:
 - "No Smoking" signs shall be prominently displayed at all entrances
 - Additional signs shall be posted in strategic locations throughout the campus
 - Signs shall include information about penalties for violations



2. Enforcement:

- Security personnel shall monitor compliance
- All University officials and employees are deputized to report violations
- A reporting system shall be established for violations

3. Support Services:

- The University Health Services shall provide smoking cessation programs
- Counseling services shall be available for those seeking to quit
- Educational campaigns shall be conducted regularly

IV. PENALTIES

Violations of this policy shall be subject to disciplinary action in accordance with:

For Students:

Penalties shall be imposed as prescribed in the Romblon State University Student Manual and Code of Conduct.

For Faculty and Staff:

Penalties shall be imposed in accordance with Civil Service Commission Memorandum Circular No. 17, s. 2009 and CSC-DOH Joint Memorandum Circular 2010-01

First Offense: Written reprimand

Second Offense: Suspension for one (1) day to thirty (30) days

Third Offense: Dismissal from service

For Visitors:

First Offense: Verbal warning and escort from premises

Subsequent Offenses: Ban from entering University premises

V. EFFECTIVITY

This memorandum shall take effect immediately and shall be strictly enforced.
